Next Generation Trading (NGT):

User fees are priced based on the number of trading transactions matched through the EquiLend platform. Rejected or unmatched orders are not counted toward transaction totals. Clients are billed quarterly in arrears and any additional transactions will also be billed in arrears.

Any Participant may enter into an arrangement to avail of exclusive bilateral pricing subject to Rule 3.8. of MTF Rulebook Additional activity fees are subject to a tiered pricing structure and are borne by the counterparty.

INTEGRATION FEE

Integration options include Internet/browser, FTP or XML messaging. Cost is \$15,000 for a 6 to 8 week FTP or a 12 week XML/MQ integration.

Swaptimization:

Swaptimization fees are billed monthly and are calculated as an annualized one (1) basis point fee on the daily outstanding notional amount (price of the security multiplied by the number of shares) of transactions effected through the service. Swaptimization fees are separate from fees for other EquiLend functions and service.
